4. FIRST-AID MEASURES

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Steps to be Taken In Case Material Is Released or Spilled: Gather in plastic bag and place in steel drum. Do not reuse gathering device (broom).

7. HANDLING AND STORAGE

Precautions to be Taken in Handling and Storing: Only store in plastic lined containers.

Before Using: Keep sealed in plastic lined container. Do not allow material to become dusty.
